

Q1 Do you support the Council's commitment to enhance biodiversity by at least 10% on our green spaces by 2025?





Q2 Do you support the Council in its aim to improve the opportunities for wildlife at its existing green spaces?





Q3 Would you like the Council to relax its cutting regime where it does not conflict with formal and informal recreation?





Q4 Would you like areas of long grass to be left on some verges and on peripheries of parks?






Q6 Would you like to see areas of new wildflower planting on our green spaces?
